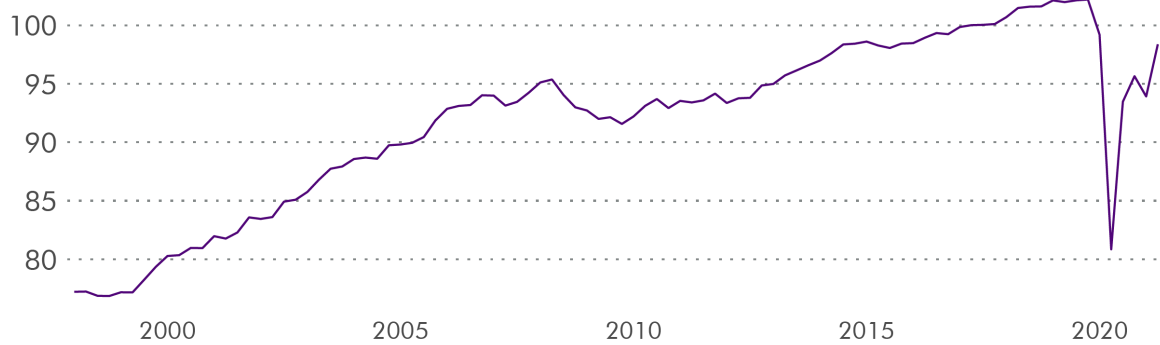

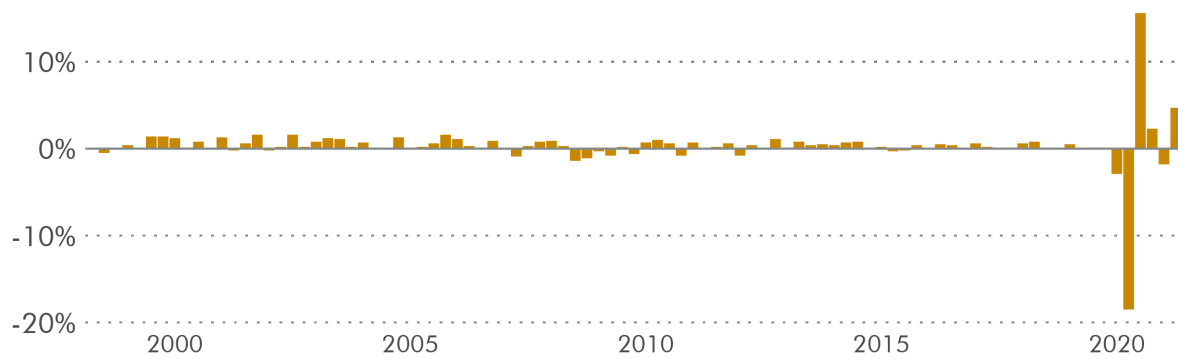
This infographic looks at the latest data from the Scottish Government on Scotland's quarterly economic output.

Total output and how it has changed

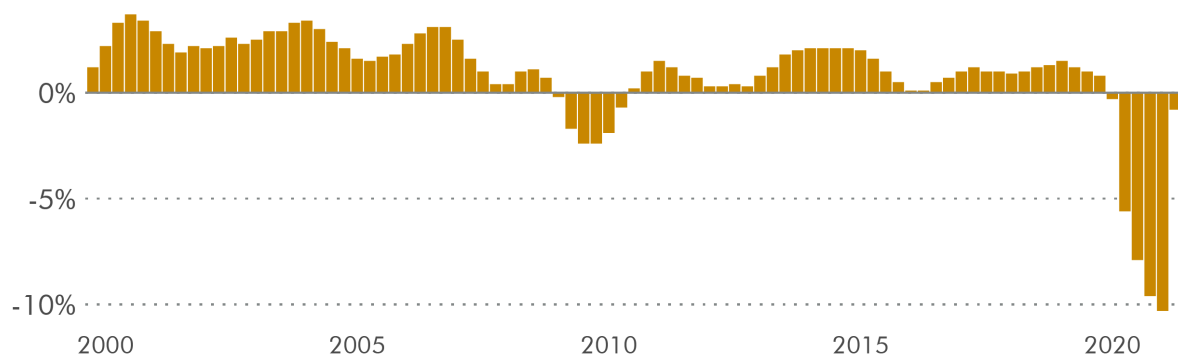
Index (2017=100)

Percentage change for latest four quarters compared with previous four quarters

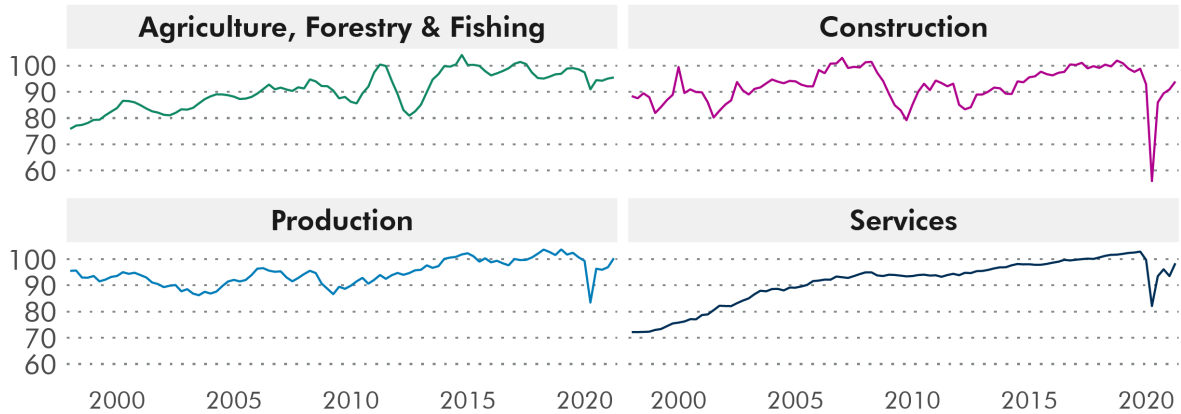

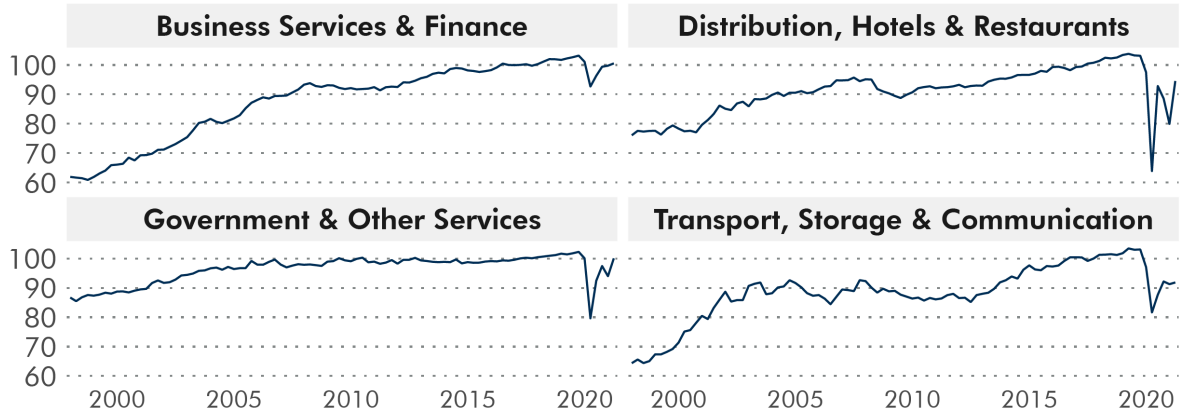

Services make up around 77% of the Scottish economy

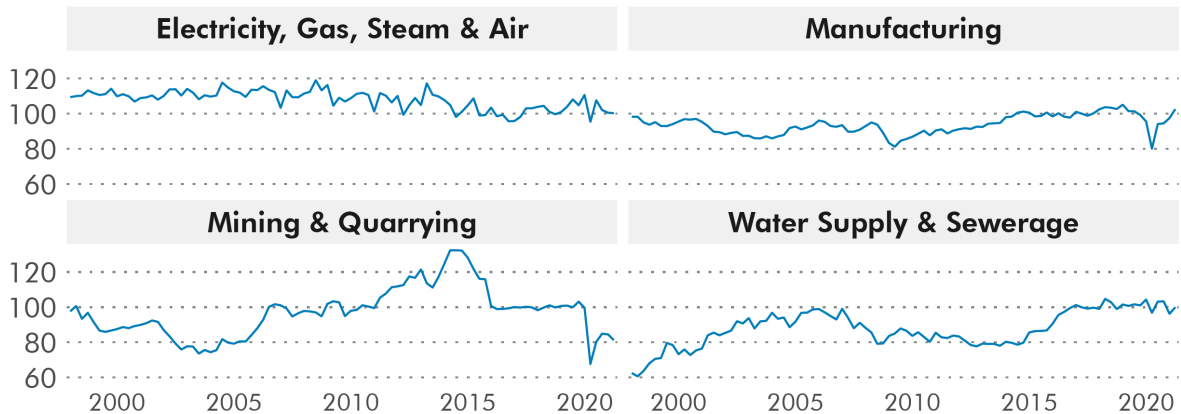

About the data

This publication looks at the data on Scottish GDP published by the Scottish Government. It is pulled directly from the Gross Domestic Product: Quarterly Output by Industry1 section on the [statistics.gov.scot website](https://www.statistics.gov.scot).

Key points about the data: •

- The data used is for the "onshore economy" meaning it does not include output from the North Sea.
- The data is in real terms. This means growth rates have been adjusted to have the effect of price changes removed.
- The data has been seasonally adjusted.
