# **Delegated Powers and Law Reform Committee**

The remit of the Delegated Powers and Law Reform Committee is to consider and report on the following (and any additional matter added under Rule 6.1.5A)—

- (a) any—
- (i) subordinate legislation laid before the Parliament or requiring the consent of the Parliament under section 9 of the Public Bodies Act 2011;
- (ii) [deleted]
- (iii) pension or grants motion as described in Rule 8.11A.1; and, in particular, to determine whether the attention of the Parliament should be drawn to any of the matters mentioned in Rule 10.3.1;
- (b) proposed powers to make subordinate legislation in particular Bills or other proposed legislation;
- (c) general questions relating to powers to make subordinate legislation;
- (d) whether any proposed delegated powers in particular Bills or other legislation should be expressed as a power to make subordinate legislation;
- (e) any failure to lay an instrument in accordance with section 28(2), 30(2) or 31 of the 2010 Act;
- (f) proposed changes to the procedure to which subordinate legislation laid before the Parliament is subject;
- (g) any Scottish Law Commission Bill as defined in Rule 9.17A.1; and
- (h) any draft proposal for a Scottish Law Commission Bill as defined in that Rule.
- (i) any Consolidation Bill as defined in Rule 9.18.1 referred to it in accordance with Rule 9.18.3.

## Introduction

- 1. At its meeting on 22 February, the Committee considered 20 instruments under its remit.
- 2. The Committee determined that it did not need to draw the Parliament's attention to 18 of the instruments considered. These are listed in the next section of the report. Additional details are provided for the relevant committee's consideration in relation to the Health Protection (Coronavirus) (Requirements) (Scotland) Amendment (No. 4) Regulations 2022 (SSI 2022/draft).
- 3. The Committee also agreed to defer the consideration of two instruments to its next meeting. These are:
  - Coronavirus Act 2020 (Alteration of Expiry Date) (Scotland) Regulations 2022 (SSI 2022/40); and
  - Health Protection (Coronavirus, Restrictions) (Directions by Local Authorities) (Scotland) Amendment Regulations 2022 (SSI 2022/Draft).

- The instrument extends the date on which the Health Protection (Coronavirus) (Requirements) (Scotland) Regulations 2021 expire from 28 February to 24 September 2022.
- The 2021 regulations make provision for the collection and sharing of information by businesses such as restaurants, cafes, bars, and pubs. They also require the wearing of face coverings in certain indoor settings and on public transport, and provide for vaccine passports or proof of a negative test.
- Some concerns were raised on the instrument.
- The Committee therefore voted and agreed, by division, that no points arose on the instrument and was content not to draw the Regulations to the attention of the Parliament:
