Early Years Assistance (Best Start Grants) (Scotland) Regulations 2018 [draft]

The Committee reports to the Parliament as follows—

- The Early Years Assistance (Best Start Grants) (Scotland) Regulations 2018 [draft] was laid before the Parliament on 11 September 2018 and referred to the Social Security Committee.
- 2. The Early Years Assistance (Best Start Grants) (Scotland) Regulations 2018 [draft] is subject to the affirmative procedure (Rule 10.6). It is for the Social Security Committee to recommend to Parliament whether the Regulations should be approved.
- 3. The purpose of this instrument is to provide detailed rules relating to the Best Start Grant Pregnancy and Baby payment only. The regulations cover eligibility, including residence, what assistance is available, the value of the payments and when to apply. The regulations also include provision for timescales for the processing of redeterminations and certain issues of process relating to application dates.
- 4. The Delegated Powers and Law Reform Committee considered this instrument at its meeting on 18 September 2018 and agreed that it did not need to draw it to the attention of the Parliament.
- 5. Following the evidence session, Shirley-Anne Somerville moved motion S5M-14101
