Early Years Assistance (Best Start Grants) (Scotland) Amendment (No. 1) Regulations 2019 [draft]

The Committee reports to the Parliament as follows—

- The Early Years Assistance (Best Start Grants) (Scotland) Amendment (No. 1)
 Regulations 2019 [draft] was laid before the Parliament on 18 January 2019 and
 referred to the Social Security Committee.
- 2. The Early Years Assistance (Best Start Grants) (Scotland) Amendment (No. 1) Regulations 2019 [draft] is subject to the affirmative procedure (Rule 10.6). It is for the Social Security Committee to recommend to Parliament whether the Regulations should be approved.
- 3. The purpose of this instrument is to amend the definitions of "application window" and "dependent", extend provision for determination without application in certain situations and adjusts a resident rule should the UK leave the European Economic Area. The regulations also provide clarification that Sure Start Maternity Grant recipients are not also eligible for the Best Start Grant.
- 4. The Delegated Powers and Law Reform Committee considered this instrument at its meeting on 29 January 2019 and agreed that it did not need to draw it to the attention of the Parliament.

- 8. The Early Years Assistance (Best Start Grants) (Scotland) Amendment (No. 2) Regulations 2019 [draft] was laid before the Parliament on 18 January 2019 and referred to the Social Security Committee.

- 16. The Funeral Expense Assistance (Scotland) Regulations 2019 [draft] is subject to the affirmative procedure (Rule 10.6). It is for the Social Security Committee to recommend to Parliament whether the Regulations should be approved.
- 17. This instrument will provide a duty on Scottish Ministers to deliver a one-off payment to support people on certain benefits or tax credits by providing a contribution towards the cost of a funeral. The Regulations include provision for eligibility, including residence of both the applicant and the deceased; what assistance is available, and when to apply.
- 18. The Delegated Powers and Law Reform Committee considered this instrument at its meeting on 29 January 2019 and agreed that it did not need to draw it to the attention of the Parliament.
